- As part of the initiatives and for the well-being of the members of the Company to curb the spread
  of COVID-19, the AGM of YLI Holdings Berhad ("YLI" or the "Company") will be held entirely
  through live streaming and online remote voting via Remote Participation and Voting ("RPV")

With the Virtual Meeting Facilities, you may exercise your right as a member of the Company to participate (including the right to pose questions to the Board of Directors and/or Management of the Company) and vote at the AGM. Alternatively, you may also appoint the Chairman of the meeting as your proxy to attend and vote on your behalf at the AGM.

## **Entitlement to Participate and Appointment of Proxy**

- Members/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from 11.00 a.m. on Tuesday, 30 August 2022 but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to "Procedures to Remote Participation and Voting via RPV Facilities" provided above for guidance on how to vote remotely via TIIH Online.
- Upon completion of the voting session for the AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
